ARTICLE I. CORPORATE NAME

The name of this Corporation is C.R.M. Worm Ranch, Inc.

ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III. NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is to engage in any business as permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK


The maximum number of share of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock without par value.

ARTICLE VII. BOARD OF DIRECTOR (S)

This Corporation shall have six Director(s) initially. The number of Director(s) may be increased or decreased from time to time by bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE VIII. INITIAL DIRECTOR (S)

The name of the initial director(s) of this Corporation and their street address is James R. Cole, Jr. and Michele G. Cole at 9111 Regents Park Drive, Tampa, FL 33647 and John Rowles and Kimberly Rowles at 7920 Cameron Cay Court, New Port Richey, FL 34653 and Donald W. Minton and LeAnne M. The persons named initial director shall hold office for the first year of existence of this Corporation or until their successor is elected or appointed and has qualified whichever occurs first.

ARTICLE IX. INCOPORATOR

ARTICLE X. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.


ARTICLE XI. PRE-EMPTIVE RIGHTS
