**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
ON TIME HEAVY EQUIPMENT HAULING, INC.  
(Document No. P02000086310)**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

The name of the corporation is ON TIME HEAVY EQUIPMENT HAULING, INC., a Florida corporation (hereinafter referred to as the "Corporation").

Article II - Amendment

Article I of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

"The name of the corporation is LORENZO DAVIS, INC."

Article III of the Articles of Incorporation of the Corporation is amended to read in its entirety as follows:

The purposes for which this corporation is organized is all lawful purposes.

The remainder of the Articles of Incorporation are unchanged and shall remain in full force and effect.

Article III - Effective Date of Amendment
