# ARTICLES OF INCORPORATION OF EXQUISITE KOSHER CATERING, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

#### ARTICLE ONE

NAME

The name of the corporation is Exquisite Kosher Catering, Inc.

#### ARTICLE TWO
