

The undersigned, for the purposes of foregoing a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I

Corporate Name & Address

LA CEIBA LABOR POOL, INC.

The name of the corporation shall be *LA CEIBA LABOR POOL, INC.* and the address is 3808 Rampart Drive Orlando, Fl 32812.

ARTICLE II

Term of Existence

The duration of the corporation is perpetual, to be commenced with the filing of the articles of incorporation with the Department of State of the State of Florida.

ARTICLE III

Nature of Corporate Business

The general purpose for which the corporation is organized is:

1. to engage in a contract labor organization and to do that which is incidental to the foregoing in order to accomplish the foregoing; and






