The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE

NAME AND ADDRESS

The name of the corporation is DRAGONSONGS CORP, and its initial address is 10145 NW 9 ST. #205, MIAMI, FL 33172

CORPORATE DURATION

The duration of the corporation is perpetual.

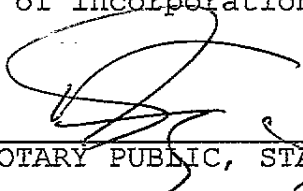

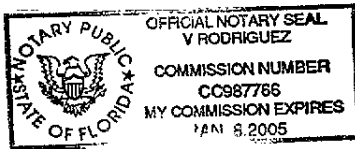
