**ARTICLES OF INCORPORATION
OF
SARAVEST FINANCIAL COPROPRATION**

The undersigned subscribes to these Articles of Incorporation, each a natural person competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Saravest Financial Corporation

ARTICLE II - NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and of this state.

ARTICLE III - CAPITAL STOCK

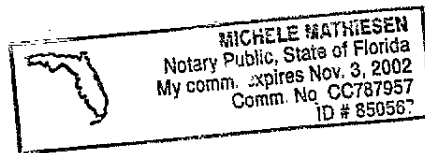
