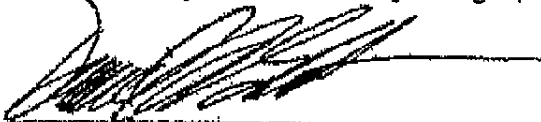
ARTICLE 8 - CAPITAL STOCK

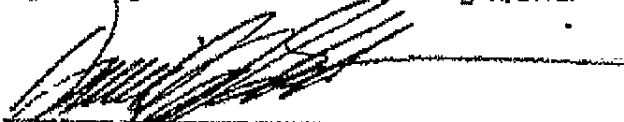
