**ARTICLES OF INCORPORATION  
OF  
A BOUNCE AROUND RENTALS, INC.**

**ARTICLE I**

The name of the corporation is A BOUNCE AROUND RENTALS, INC. (the "Corporation").

**ARTICLE II**

The street address of the Corporation's principal office is 16234 Keylime Blvd., Loxahatchee, Florida 33470, and the Corporation's mailing address is P.O. Box 186, Loxahatchee, Florida 33470.

**ARTICLE III**

This Corporation shall have authority to issue One Thousand (1,000) shares of Common Stock having a par value of \$0.01 per share.

**ARTICLE IV**

The Corporation shall hold a special meeting of shareholders only:

- (1) On call of the Board of Directors or persons authorized to do so by the Corporation's Bylaws; or
- (2) If the holders of not less than 50 percent of all votes entitled to be cast on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

**ARTICLE V**

The name and address of the Corporation's initial registered agent is Mechelle King, 16234 Keylime Blvd., Loxahatchee, Florida 33470.

**ARTICLE VI**

The Board of Directors of the Corporation shall consist of at least one director, with the exact number to be fixed from time to time in the manner provided in the Corporation's Bylaws. The number of Directors constituting the initial Board of Directors is four (4), and the names of the members of the initial Board of Directors, who are to serve as the Corporation's directors until successors are duly elected and qualified are:

**ARTICLE VIII**


This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by law in existence either now or hereafter.
