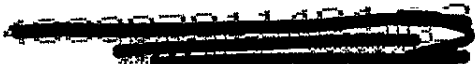

ARTICLE I - NAME

The name of this corporation is: GCH ENTERPRISES, INC.

ARTICLE II - DURATION


ARTICLE IX - INDEMNIFICATION


