I, the undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of Incorporation:

ARTICLE I.Name of Corporation

The name of this corporation shall be

ARTICLE IIPrincipal Office

ARTICLE IIITerm of Existence

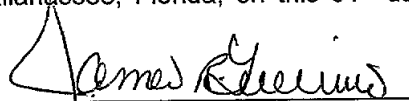

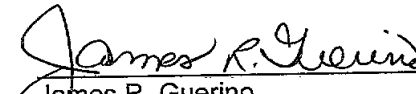
