ARTICLES OF INCORPORATION
OF
T & T INVESTMENT & DEVELOPMENT CORP.

ARTICLE I - Name

The name of this corporation is T & T INVESTMENT & DEVELOPMENT CORP.

ARTICLE II - Duration

The period of its duration is perpetual.

ARTICLE III - Purpose
