**ARTICLE I: NAME**

The name of the corporation is: Exotic Marble & Granite Design Corporation

**ARTICLE II: NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is to do all things which natural persons might lawfully do in the premises as follows: Design, fabrication and installation of marble, granite and other surfaces and related products and services and investments of every kind, nature and description.
