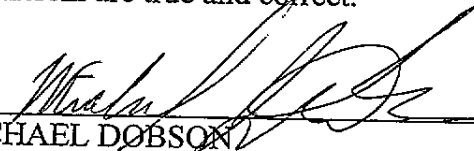
ARTICLE VIII
