ARTICLES OF INCORPORATION
OF
CHARLES CONSTRUCTION CORPORATION
A FLORIDA CORPORATION

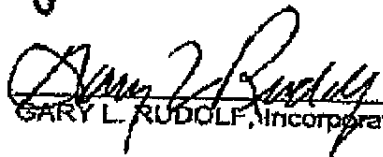
