ARTICLES OF INCORPORATION

OF

COLUMBIA MINT, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is Columbia Mint, Inc.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 6960 Bonneval Road, Suite 102, Jacksonville, Florida 32216.

ARTICLE II

DURATION

Section 2.1 <u>Duration</u>. This corporation shall exist perpetually.
