ARTICLES OF INCORPORATION OF

PARIS TROPIC, INC., A Florida Corporation



Article I NAME

The name of this Corporation is **PARIS TROPIC, INC.**, a Florida corporation.

Article II TERM OF EXISTENCE

Pursuant to the provisions of Florida Statutes, the existence of the Corporation shall commence upon filing of these Articles. The Corporation shall have perpetual existence thereafter unless dissolved pursuant to Florida Statutes.

Article III NATURE OF BUSINESS

This Corporation is organized for the following purpose:
To engage in any and all lawful business.
