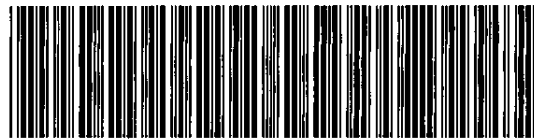

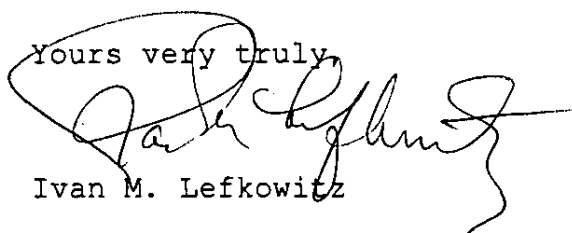

Pursuant to Section 607.1006 of the Florida Statutes, DATAFORCE MEDICAL STAFFING, INC. (the "Corporation"), a corporation organized and existing under the laws of the State of Florida, under Document Number P02000087796, filed in the office of the Secretary of State on August 13, 2002, certifies as follows:

1. The directors and shareholders of the Corporation considered amending the Articles of Incorporation in order to change the name, and after discussion, it was

RESOLVED, that the Articles of Incorporation of DATAFORCE MEDICAL STAFFING, INC. be amended to change the name from DATAFORCE MEDICAL STAFFING, INC. to DATAFORCE PROFESSIONAL SERVICES, INC., and that Article I shall be amended to read in its entirety as follows:

"ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be
DATAFORCE PROFESSIONAL SERVICES, INC."
