**ARTICLES OF INCORPORATION
OF
SUMMIT COMMUNITY GROUP, INC.**

Pursuant to Chapter 607, Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Summit Community Group, Inc..

ARTICLE II

The existence of the Corporation shall begin on August 12, 2002.

ARTICLE III

The street address of the principal office of the Corporation is 327 Office Plaza Drive, Suite 208, Tallahassee, FL 32301.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 10,000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial board of directors shall consist of six (6) members. ARTICLE VIII


The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
