The number of shares of common stock that this corporation is authorized to have outstanding at any one time is 100 (one hundred).

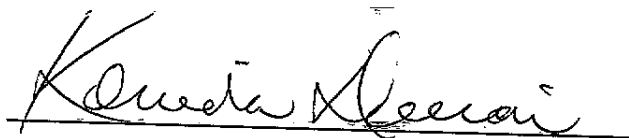

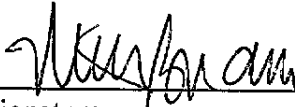

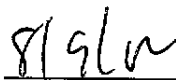
