ARTICLE I - NAME

The name of the corporation formed pursuant to these Articles of Incorporation is
Trilogy Partners Corp.

ARTICLE II - DURATION

The corporation shall exist perpetually, commencing on the date of filing of these
Articles of Incorporation with the Secretary of State, State of Florida.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business
for which corporations may be incorporated under Chapter 607, *Florida Statutes*.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 10,000 shares of \$.01 par value common
stock.

The corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.


ARTICLE XI - AFFILIATED TRANSACTIONS
