I the undersigned, hereby form this corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation of a corporation for profit

**ARTICLE I**

**NAME OF CORPORATION**

The name of this corporation shall be: Jennings Electric and Building, Inc.

**ARTICLE II**

**GENERAL NATURE OF BUSINESS**

The general nature of the business and the purposes proposed to be transacted, promoted and carried on are as follows: to engage in the electrical and general contracting business and to carry on any other lawful business whatsoever permitted by the laws and statutes of the State of Florida and the United States.

**ARTICLE III**

**SHARES**

The authorized capital stock of the corporation shall be: 1000 shares at \$1.00 par value per share.

**ARTICLE IV**

**ARTICLE VII**

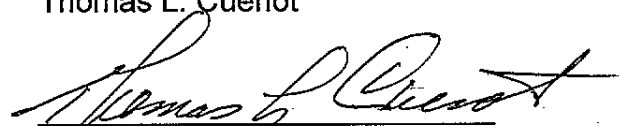
