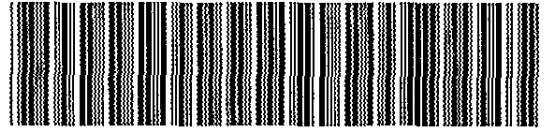

to
ARTICLES OF INCORPORATION
