Amendment



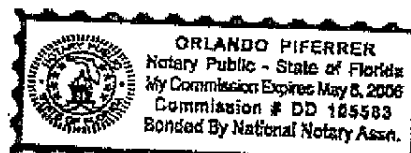
