The Articles of Incorporation of Big Color Output USA, Inc., were filed with the Secretary of State of Florida, Division of Incorporation on August 14, 2002 as document number P02000088121.

ARTICLE 2

Said Articles of Incorporation were filed with an inaccuracy as that term is used in Section 607.0124, Florida Statutes.

ARTICLE 3

The inaccuracy was giving the incorrect first name of an initial director named in the said Articles of Incorporation as "Thomas" J. Watson in Article VI thereof. Thomas J. Watson is not a person involved in the organization of the Corporation and the use of the name "Thomas" in the Articles of Incorporation was the result of a scrivener's error in the offices of the undersigned sole incorporator.


ARTICLE 4
