ARTICLE I - NAME

ARTICLE II - DURATION

The corporation shall have perpetual existence, commencing upon the filing of the Articles with the office of the Secretary of State.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business, including all powers necessary or convenient to effect its purposes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issued 1,000 shares of common stock with a par value of Ten Cents (\$.10) per share.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have 1 director initially. The number of directors may be either increased or decreased from time to time by the Bylaws, but shall never be less than 1.

ARTICLE VIII - INCORPORATION/PRINCIPAL ADDRESS

## ARTICLE IX - BYLAWS

Bylaws may be repealed or amended, and new Bylaws may be adopted by either the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by shareholders if the shareholders specifically provide such bylaws are not subject to amendment or repeal by the directors.

At each election for directors every shareholder entitled to vote at such election shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected at that time multiplied by the number of his shares, or by distributing such votes on the same principle among any number of such candidates.

The approval of the shareholders of this corporation to any plan or merger shall be required in every case, whether or not such approval is required by law.

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation

ARTICLE XIII - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XIV - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation. GP

ARTICLE XV - DIRECTORS' COMPENSATION

The shareholders of this corporation shall have the exclusive authority to fix the compensation of the directors of this corporation. GP

ARTICLE XVI - ASSETS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act, except that this corporation shall not have the power to sell, mortgage or pledge all or substantially all of its property and assets without prior shareholders' approval. GP

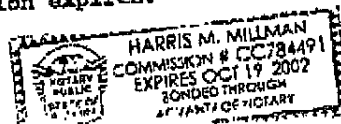
