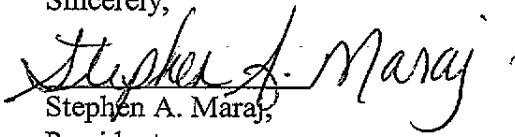

ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the STATE OF FLORIDA providing for the information, liability, rights, privileges and immunities of corporation for profit.

ARTICLE I, NAME

The name of the corporation shall be :
MARAJ CO., INC.

ARTICLE II, NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III, CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one hundred (100) shares of common stock, with value of one dollar (\$1.00) per share.

ARTICLE IV, INITIAL CAPITAL

The amount of capital with which this corporation will begin business will not be less than one hundred dollars (\$100.00).

ARTICLE V, TERM OF EXISTENCE

This corporation is to have perpetual existence.

ARTICLE XI, REGISTERED AGENT AND REGISTERED OFFICE

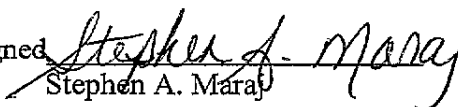

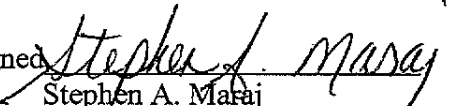

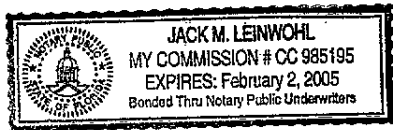
