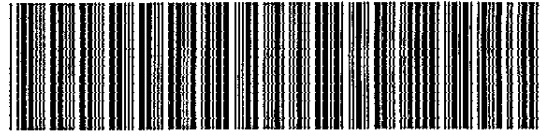

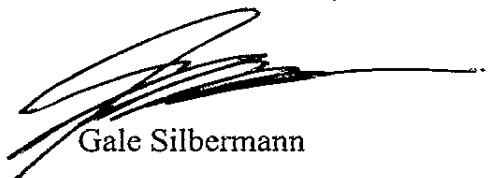

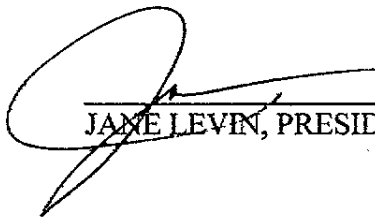
1. The name of the corporation is LEVIN LaBRAKE ASSOCIATES INVESTMENT REALTY CORP.
