

ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE - NAME

The name of the corporation is Silver Stirrup Stables, Inc.


