I was recently received a notice from your office indicating that I had not filed a 2003 Uniform Business Report (UBR) or paid the appropriate fee. The notice also indicated that a \$400.00 penalty had been assessed since I missed the May Ist deadline.

Not knowing exactly what this was, I asked my accountant. He explained to me that I should have paid the annual renewal fee (of \$150.00) on or before May 1, 2003 to keep my corporation active in your system. He explained that I should have received an original Uniform Business Report from your office in January or February, and described what the form looked like.

I do not recall receiving such a form from your office. I believe that the problem is that I relocated my home/office early this year. As such, the mailing address for my corporation changed from "4715 Sea Star Vista, Destin, FL 32541" to "421 Maritime Court, Destin, FL 32541". I believe that the original form was sent to my old address, and not properly forwarded to me. I have changed my address as shown on the attached UBR.

Also, I am new in Florida (I changed my corporation from Missouri to Florida during 2002) so that the 2003 Uniform Business Report would have been the first one that I was required to file.
