Nothing contained in these Articles of Incorporation shall limit or preclude the exercise of any right relating to indemnification or advancement of attorney's fees and expenses to any person who is or was an officer or director of the Corporation.

The incorporator resigns all powers, duties and obligations on the date of filing of the Articles of Incorporation.
