The undersigned incorporator adopts the following Articles of Incorporation for purposes of forming a corporation under the Florida Business Corporation Act:

**1. Name**

The name of the Corporation is SecOne Corporation. The Corporation's initial principal office (and mailing address) is located at 7321 Howard Road, Bokeelia, Florida 33922.

**2. Capital Structure**

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any time is ten million (10,000,000) shares of common stock having one-cent (\$.01) par value per share.

**3. Term of Existence**


