The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby accepts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the Corporation is **TRPKOVSKI PRIMARY CARE, P.A.**

**ARTICLE II  
DURATION**

The term of existence of the Corporation is perpetual.

**ARTICLE III  
PURPOSE**

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act. The Professional Association will provide medical services, as permitted under Florida law.

**ARTICLE IV  
CAPITAL STOCK**
