Pursuant to chapter 607 of the Florida Statutes, the undersigned incorporator adopts these articles of incorporation for the purpose of forming a for-profit corporation.

- Article 1:** The name of the corporation is:
Shed Ramp, Inc.
- Article 2:** The principal place of business and mailing address of the corporation is Rt. 3 Box 1273, Starke, FL. 32091
- Article 3:** The corporation is authorized to issue two classes of stock: (a) 1 million shares of common stock with no par value and (b) 1 million shares of preferred stock with no par value. The transfer of all stock is restricted according to the bylaws of the corporation.
