

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Article of Incorporation.

Article 1. Name.

The name of the Corporation is

Article 2. Duration.

The duration of the Corporation is perpetual

Article 3. Purpose.

The general purpose of the Corporation is as follows:

A. To engage in and transact any lawful business for which corporation s may be incorporated under the Florida General Corporations Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

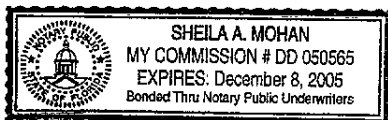
