ARTICLES OF INCORPORATION OF A. LAWRENCE SERVICES, INC. A Florida Corporation

ARTICLE IX. AMENDMENTS

This corporation reserves the right to amend alter, change or repeal any provision contained herein in the manner now or hereafter prescribed by law, and all rights conferred on stockholders herein are granted subject to this reservation.
