**ARTICLES OF INCORPORATION  
OF  
JOHN & STEVE TRUCKING, INC.**

**ARTICLE I - NAME**

The name of this corporation is JOHN & STEVE TRUCKING, INC. (hereinafter referred to as the "Corporation").

**ARTICLE II - DURATION**

The Corporation shall have perpetual existence commencing on the date of filing these Articles with the Department of State.

**ARTICLE III - PURPOSE**


