I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

This corporation shall commence its existence immediately upon the filing of these Articles of incorporation and shall exist perpertually thereafter unless sooner dissolved according to law.
