ARTICLE VIII. INCORPORATOR

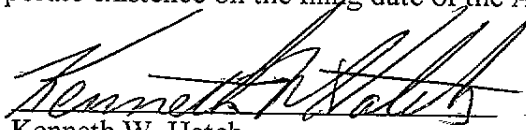

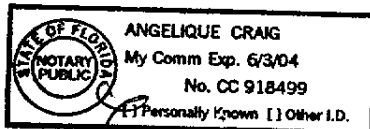
