ARTICLES OF INCORPORATION OF AMJ GROUP, INC.

A FLORIDA CORPORATION

The undersigned, acting as incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is AMJ GROUP, INC.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of the Corporation has not yet been established. The current mailing address of the Corporation is 3395 N. Dixie Highway, Suite 4, Boca Raton, Florida 33481.

ARTICLE III

CAPITAL STOCK
