OF

Corporation under Chapter 607 of the laws of

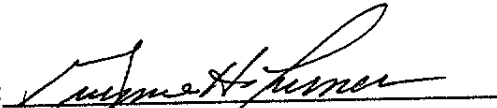

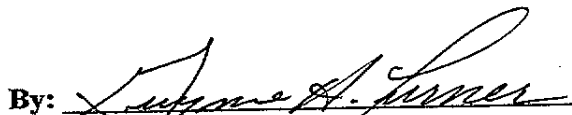
