The undersigned subscriber to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.....

ARTICLE I - NAME

The name of the corporation is:

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be: Import and export to the real estate development, and any and all activities permitted under the Laws of the United States of America.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is: 5,000,000 SHARES

All the aforementioned stock is to be issued and partially paid for and exempt from assessment.

The capital stock may be paid for in money, property, labor, or services, at a just valuation to be fixed by the incorporation or by the directors at a meeting called for such purpose.

ARTICLE IV - INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is not less than: 5,000,000 SHARES AT \$0.02 PAR VALUE

ARTICLE V - TERM OF EXISTENCE


ARTICLE XII - AMENDMENT
