ARTICLES OF INCORPORATION  
OF

In compliance with Chapter 607 and/or Chapter 621, Florida Statutes.

**ARTICLE I - NAME**

The name of the corporation shall be OrtCon Music Productions, Inc.

**ARTICLE II - PRINCIPAL OFFICE**




