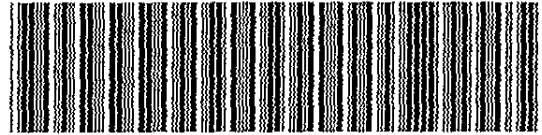

SECOND: The Corporation's articles of incorporation were filed on August 20, 2002 and assigned document number P02000090411.

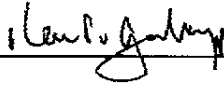
THIRD: The Corporation has not commenced business.
