FOR

**ARTICLE I  
NAME OF CORPORATION**

The name of the corporation shall be INFOQUEST PUBLISHING, INC.

**ARTICLE II  
PRINCIPLE OFFICE**

The principal place of business of this corporation shall be:

St. Petersburg, FL 33716

**ARTICLE III  
PURPOSE**

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- A. The corporation shall be a retail and/or wholesale publishing corporation. Its authorizations include carrying on research and studies, preparing and publishing treatises, articles, newsletters, pamphlets, books and other educational materials. It furthermore reserves the right to publish, print and distribute said materials. Supplementary authorizations include public and private sale and/or auction of said materials, including but not limited to retail and/or wholesale of similar and ancillary materials, products, goods and services and other inventories and/or services necessary and proper to carry out such authorizations under applicable sections of the Florida Statutes and the Laws of Florida.
- B. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental there to which is not forbidden under the laws of the State of Florida.

**ARTICLE IV  
CAPITAL STOCK**

- A. The maximum shares of stock that the corporation is authorized to have outstanding at any time shall be 1,000 shares of common stock at \$1.00 per share par value.
