The undersigned incorporator does hereby make, subscribe, file and acknowledge these EFLORIDA Articles of Incorporation for the purpose of organizing a corporation under the Florida Business Corporation Act.

# ARTICLE I: NAME OF CORPORATION

The name of the Corporation shall be Tesdane Nanny Consultants, Inc.

#### ARTICLE II: PURPOSE

The purpose for which this Corporation is organized is to engage in any lawful activity or to transact any lawful business for which corporations may be incorporated pursuant to the Florida Business Corporation Act, Chapter 607, Florida Statutes, as amended.
