ARTICLE I - NAME

The name of this Corporation is Contract Furniture Systems, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on August 21, 2002.

ARTICLE III - PURPOSE

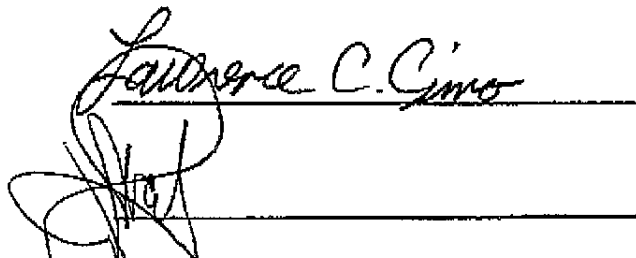
ARTICLE XI - BY-LAWS
