ARTICLES OF INCORPORATION OF MASTER CARPENTRY, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit, Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is MASTER CARPENTRY, INC., hereinafter referred to as the "Corporation."

ARTICLE 2 - PURPOSE OF CORPORATION
