ARTICLES OF INCORPORATION

OF

ESTE GROUP, INC.

BY THESE ARTICLES OF INCORPORATION, the undersigned acting as incorporated pursuant to the Florida General Corporation Act, forms a corporation for profit.

ARTICLE I

ARTICLE IV

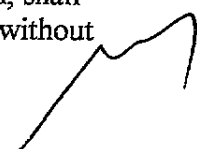

The purpose of this corporation is to transact any and all lawful business for which the Corporation may be incorporated under Chapter 607 of the Florida Statutes.

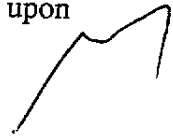

ARTICLE X

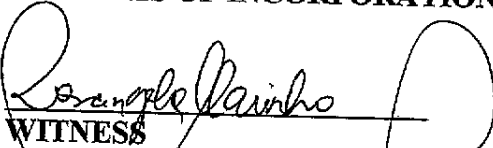
The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

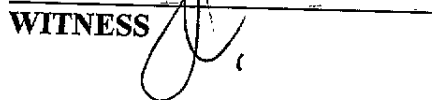

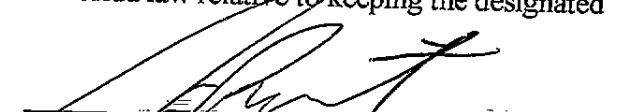
