The undersigned incorporator hereby makes, subscribes to, acknowledges and files these articles of incorporation for the purpose of organizing and incorporating a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be:

CENTRAL FLORIDA HOME INSPECTORS, INC.

And shall hereinafter be referred to as the "corporation".

ARTICLE II

The time and date on which corporate existence of this corporation shall begin at 12:01 o'clock A.M.(Eastern Standard Time) on August 20., 2002, and this corporation shall have a continuous and perpetual existence thereafter.



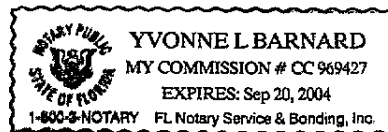

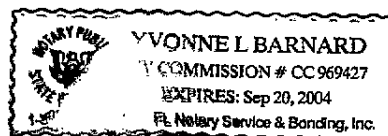
