

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Actione "Act"), as follows:

I. Name

The name of the Corporation is AMC Industries, Inc.

П. Term of Existence

The date when corporate existence will commence is August 20, 2002 in accordance with the provisions of Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.
